Dear Friends/Community Leaders,

We'd like to invite you to participate in our 10th Annual "**Senior Fest 2009 Info/Expo**", **Friday, October 9, 2009**, 8:30 a.m. till 2:00 p.m. at the Melbourne Auditorium, 625 E. Hibiscus Blvd., Melbourne, FL 32901. The festivities will begin with a fitness walk around the lake and continue inside with space for more than 90 vendors. Health First Health Systems will sponsor our health fair this year. Free food and demonstrations on a variety of topics will keep the event going through the afternoon. Last year, we had over 1,200 visitors. **Non-profits must include a copy of your Florida non-profit status letter with your registration.**

Non-Profit tables are available for \$50 for a full table and \$25 for a 1/2 table. For profit tables are \$275 with \$75 of this due with your reservation. All vendors are required to stay until the close of the Expo at 2:00 p.m. Tables will be covered, skirted and marked with the name of your organization. A layout map will be given to you when you arrive to help you find your table location. Set up time is 7:15 to 8:15 a.m. and our doors will open to the public at 8:30 a.m. Up to two Box lunches will be provided to each vendor and will be available between 11:30 a.m. and 12:30 p.m. If space allows, we will provide a lounge for vendors and staff to enjoy their free lunch away from the crowd.

Admission and parking are free for all visitors to the Expo. Each visitor will be given a "Passport" that needs to be initialed by at least 10 vendors, this then becomes their free lunch ticket. We encourage giveaways and if you wish to give away door a prize at the Expo please indicate that on your registration form. **You will be responsible for registering visitors at your table for your drawing(s).**

There can be no sales at the Expo. You may gather voluntary information on those interested in your products or services **but may not have any exchange of money for products or services.**

To reserve your table, send your registration form with your \$50 fee (for non-profits) or \$75 deposit for other vendors, to the address listed below **no later than August 14, 2009.** Checks should be made payable to Brevard County TRIAD, Inc.
